NOTICE is hereby given that the Naples City Council will consider enactment of the following ordinance upon Second Reading at the Regular City Council meeting to be held on Wednesday, May 4, 2016, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

AN ORDINANCE RELATING TO REGULATION OF THE WATERWAYS OF THE CITY OF NAPLES, FLORIDA; AMENDING SECTION 1-15, GENERAL PENALTY; CONTINUING VIOLATIONS; ADJUDGING FINES AND IMPRISONMENTS, OF CHAPTER 1, GENERAL PROVISIONS; AMENDING SECTION 42-172, AREA OF ENFORCEMENT; FOR SPECIFIC AREAS OF DOCTORS PASS AND THE MOORINGS BAY SYSTEM; PROVIDING FOR CONFLICTING PROVISIONS, SEVERABILITY AND APPLICABILITY; AND PROVIDING AN EFFECTIVE DATE.

Said proposed ordinance may be inspected by the public at the office of the City Clerk, Room B, City Hall, 735 Eighth Street South, Naples, Florida.

All persons are invited to appear and be heard with respect to said proposed ordinance.
