AN ORDINANCE RELATING TO BUILDING FEES; AMENDING SECTIONS 16-54, PLAN REVISIONS, AND 16-55 (a) AND (c), INSPECTION FEES, OF THE CODE OF ORDINANCES, CITY OF NAPLES, IN ORDER TO ALLOW WAIVER OF CERTAIN FEES UNDER CERTAIN CIRCUMSTANCES BY THE BUILDING OFFICIAL; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.
