**NOTICE** is hereby given that the Naples City Council will consider enactment of the following ordinance upon Second Reading at the Regular City Council meeting to be held on Wednesday, November 2, 2016, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

AN ORDINANCE RELATING TO CONDITIONAL USES; AMENDING SECTION 58-593, CONDITIONAL USES, CODE OF ORDINANCES, CITY OF NAPLES, TO ADD RESIDENTIAL DWELLING UNITS TO THE LIST OF CONDITIONAL USES IN THE C-2 GENERAL COMMERCIAL ZONING DISTRICT AND SETTING A DENSITY LIMIT FOR RESIDENTIAL DWELLINGS; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

Said proposed ordinance may be inspected by the public at the office of the City Clerk, Room B, City Hall, 735 Eighth Street South, Naples, Florida.

All persons are invited to appear and be heard with respect to said proposed ordinance.
