NOTICE is hereby given that the Naples City Council will consider enactment of the following ordinance upon Second Reading at the Regular City Council meeting to be held on Wednesday, January 20, 2016, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

AN ORDINANCE RELATING TO ON-SITE LAUNDRY AND DRY CLEANING SERVICES; ADDING SECTION 56-131, SPECIFIC REQUIREMENTS FOR ON-SITE LAUNDRY AND DRY CLEANING SERVICES; AMENDING SECTION 58-503, CONDITIONAL USES; AMENDING SECTION 58-533, CONDITIONAL USES; AMENDING SECTION 58-563 CONDITIONAL USES; AMENDING SECTION 58-593, CONDITIONAL USES; AMENDING SECTION 58-623, CONDITIONAL USES, TO ALLOW FOR ON-SITE LAUNDRY AND DRY CLEANING SERVICES AS CONDITIONAL USES IN THE HIGHWAY COMMERCIAL (HC), RETAIL SHOPPING (C-1), COMMERCIAL CORE (C1-A), GENERAL COMMERCIAL (C2), AND WATERFRONT COMMERCIAL (C2-A) DISTRICTS OF THE CITY OF NAPLES; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

Said proposed ordinance may be inspected by the public at the office of the City Clerk, Room B, City Hall, 735 Eighth Street South, Naples, Florida.

All persons are invited to appear and be heard with respect to said proposed ordinance.

Any person who decides to appeal any decision made by the City Council with respect to any matter considered at the above hearing will need a record of the proceedings and may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be heard.
