AN ORDINANCE RELATING TO ETHICS; AMENDING ARTICLE IX, CODE OF ETHICS, OF CHAPTER 2, ADMINISTRATION, OF THE CODE OF ORDINANCES, CITY OF NAPLES, PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.
