

## **NOTICE OF PUBLIC HEARING ON PROPOSED ORDINANCES**

**NOTICE** is hereby given that the Naples City Council will consider enactment of the following ordinances upon Second Reading at the Regular City Council meeting to be held on Wednesday, February 18, 2015, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

**AN ORDINANCE RELATED TO TEXT AMENDMENTS; AMENDING SECTION 46-32 (a), OF ARTICLE II. – ADMINISTRATIVE PROCEDURES, OF THE CODE OF ORDINANCES, CITY OF NAPLES, TO ALLOW TEXT AMENDMENTS TO BE INITIATED BY OTHER THAN CITY COUNCIL OR THE PLANNING ADVISORY BOARD; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.**

**AN ORDINANCE RELATING TO PERMITTED USES IN THE FIFTH AVENUE SOUTH OVERLAY DISTRICT; AMENDING SUBSECTION (c) (1), BUILDING USES – USES PERMITTED OF SECTION 58-1134, SPECIAL PROVISIONS, TO CLARIFY THAT RESIDENTIAL USES ARE PERMITTED USES IN THE FIFTH AVENUE SOUTH SPECIAL OVERLAY DISTRICT; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.**

**AN ORDINANCE RELATING TO BICYCLE RACK PARKING CREDITS IN ZONING DISTRICTS; ADDING SUBSECTION (f), BICYCLE RACK CREDIT, TO SECTION 50-103, DESIGN AND CONSTRUCTION STANDARDS, OF THE CODE OF ORDINANCE, CITY OF NAPLES, TO ALLOW A BICYCLE RACK PARKING CREDIT IN ANY ZONING DISTRICT THAT INCLUDES NON-RESIDENTIAL USES; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.**

Said proposed ordinances may be inspected by the public at the office of the City Clerk, Room B, City Hall, 735 Eighth Street South, Naples, Florida.

All persons are invited to appear and be heard with respect to said proposed ordinances.
