

NOTICE OF PUBLIC HEARING ON PROPOSED ORDINANCES

NOTICE is hereby given that the Naples City Council will consider enactment of the following ordinances upon Second Reading at the Regular City Council meeting to be held on Wednesday, February 5, 2014, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

AN ORDINANCE RELATED TO SEAWALLS; AMENDING SECTION 46-35, EXPANDING, ENLARGING OR CHANGING A NONCONFORMITY, OF ARTICLE II, ADMINISTRATIVE PROCEDURES, BY ADDING SECTION 46-35 (d); AMENDING SECTION 52-92 (d), CONSTRUCTION OF SEAWALLS, GROINS AND OTHER BEACH EROSION CONTROL STRUCTURES, OF ARTICLE IV, WATER RESOURCES, BY ADDING SECTION 52-92 (d) (11); AND AMENDING SECTION 56-53(C), WATERWAYS AND WATERCRAFT, ADDING A MAXIMUM HEIGHT LIMITATION FOR BOATHOUSES; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

AN ORDINANCE RELATING TO DEPARTMENTS OF THE CITY; AMENDING SECTION 202 (b), GRAPHIC TABLE OF ORGANIZATION; AMENDING SECTION 2-222, DUTIES OF DIRECTOR (DEPARTMENT OF FINANCE); AMENDING DIVISION 5, DEPARTMENT OF POLICE AND FIRE, OF ARTICLE IV, DEPARTMENTS, OF CHAPTER 2, ADMINISTRATION; AMENDING SECTION 2-322, DUTIES OF DIRECTOR (DEPARTMENT OF STREETS AND STORMWATER); AMENDING SECTION 54-70, STREET NUMBERS AND NAMES; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

Said proposed ordinances may be inspected by the public at the office of the City Clerk, Room B, City Hall, 735 Eighth Street South, Naples, Florida.

All interested parties are invited to appear and be heard with respect to said proposed ordinances.
