

NOTICE OF PUBLIC HEARING ON PROPOSED ORDINANCES

NOTICE is hereby given that the Naples City Council will consider enactment of the following ordinances upon Second Reading at the Regular City Council meeting to be held on Wednesday, April 2, 2014, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

AN ORDINANCE RELATING TO UTILITIES; AMENDING SECTION 30-2, DEFINITIONS; AMENDING SECTION 30-252, SERVICE APPLICATION REQUIREMENTS; AMENDING SECTION 30-372, DEFINITIONS; AMENDING SECTION 30-373, WATER AND SANITARY SEWER CONNECTIONS AND EXTENSIONS, OF CHAPTER 30, UTILITIES, OF THE CODE OF ORDINANCES, CITY OF NAPLES, IN ORDER TO AMEND THE DEFINITION OF MULTIFAMILY EQUIVALENT RESIDENTIAL UNITS AND THE WATER AND SEWER SYSTEM DEVELOPMENT CHARGE FOR MULTIFAMILY; AND PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

AN ORDINANCE RELATED TO THE CITY FISHING PIER; AMENDING SECTION 42-53 (a), CONDUCT ON FISHING PIER AND PARKING AREA, OF CHAPTER 42, WATERWAYS, OF THE CODE OF ORDINANCES, CITY OF NAPLES, IN ORDER TO PROHIBIT THE USE OF FISH HOOKS, LURES AND BAITS HAVING MORE THAN TWO HOOKS SHARING A SINGLE SHANK; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

AN ORDINANCE RELATING TO FILLING LAKES; AMENDING SECTION 52-92 (e), FILLING LAKES; ERECTING BUILDINGS OVER LAKE, OF CHAPTER 52, RESOURCE PROTECTION STANDARDS, OF THE CODE OF ORDINANCES, CITY OF NAPLES, IN ORDER TO AMEND THE FILLING PERMIT PROCESS AND PROVIDE BETTER PROTECTION FOR THE WETLAND HABITAT OF LAKES; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

AN ORDINANCE RELATED TO CONSTRUCTION SITE REGULATIONS; AMENDING SECTION 16-291 (b) (10) d, CONSTRUCTION SITE MANAGEMENT, OF CHAPTER 16, CONSTRUCTION, REHABILITATION AND PROPERTY MAINTENANCE REGULATIONS, OF THE CODE OF ORDINANCES, CITY OF NAPLES, FOR THE PURPOSE OF DELETING THE REQUIREMENT TO PROVIDE ON-SITE SEISMIC MONITORING DURING CONSTRUCTION AND ADDING THE REQUIREMENT TO PROVIDE ON-SITE SEISMIC MONITORING DURING PILE DRIVING; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

Said proposed ordinances may be inspected by the public at the office of the City Clerk, Room B, City Hall, 735 Eighth Street South, Naples, Florida.

All interested parties are invited to appear and be heard with respect to said proposed ordinances.

Any person who decides to appeal any decision made by the City Council with respect to any matter considered at the above hearing will need a record of the proceedings and may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be heard.
