

## **NOTICE OF PUBLIC HEARING ON PROPOSED ORDINANCES**

**NOTICE** is hereby given that the Naples City Council will consider enactment of the following ordinances upon Second Reading at the Regular City Council meeting to be held on Wednesday, May 21, 2014, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

**AN ORDINANCE RELATING TO THE FIREFIGHTERS' PENSION AND RETIREMENT SYSTEM OF THE CITY OF NAPLES, FLORIDA; CREATING A NEW SECTION 29-246, DEFERRED RETIREMENT OPTION PLAN; DIRECTING THE CITY CLERK TO FILE A COPY OF THIS ORDINANCE WITH THE FLORIDA DEPARTMENT OF MANAGEMENT SERVICES, DIVISION OF RETIREMENT; PROVIDING FOR CONFLICTING PROVISIONS, SEVERABILITY AND APPLICABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**AN ORDINANCE DETERMINING REZONE PETITION 14-R3, TO REZONE APPROXIMATELY 1.02 ACRES FROM PD, PLANNED DEVELOPMENT TO A NEW PD, PLANNED DEVELOPMENT AMENDING IN ITS ENTIRETY THE EXISTING PLANNED DEVELOPMENT ORDINANCE FOR A 22 UNIT RESIDENTIAL BUILDING WITH A 161 SPACE MAXIMUM PARKING GARAGE TO EXTEND THE COMMENCEMENT DATE FOR CONSTRUCTION, TO ADD A PROVISION FOR TEMPORARY OFF-SITE PARKING DURING CONSTRUCTION, AND TO CLARIFY THE LIMITATIONS OF AMENDMENTS TO THE APPROVED PLANNED DEVELOPMENT, FOR PROPERTY OWNED BY NAPLES FIFTH AVENUE FOURTH AND FOURTH, LLC AND LOCATED AT 440 4<sup>TH</sup> AVENUE SOUTH, 460 4<sup>TH</sup> AVENUE SOUTH AND 410 4<sup>TH</sup> AVENUE SOUTH, MORE FULLY DESCRIBED HEREIN; PROVIDING A SEVERABILITY CLAUSE, AND A REPEALER PROVISION; REPEALING ORDINANCE NUMBER 08-11903; AND PROVIDING AN EFFECTIVE DATE.**

**AN ORDINANCE ADOPTING THE 2013 LEVEL OF SERVICE REPORT; AND PROVIDING AN EFFECTIVE DATE.**

**AN ORDINANCE RELATING TO UTILITIES; AMENDING SECTION 30-2, DEFINITIONS; AMENDING SECTION 30-9 MONTHLY RATES, FEES AND CHARGES, OF CHAPTER 30, UTILITIES, OF THE CODE OF ORDINANCES, CITY OF NAPLES, IN ORDER TO AMEND THE DEFINITION OF BULK WATER USER CLASSIFICATION, AND TO INCLUDE RECLAIMED WATER BASE CHARGES AND A 25 PERCENT SURCHARGE TO RECLAIMED WATER CUSTOMERS OUTSIDE THE CITY LIMITS; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.**

**AN ORDINANCE RELATING TO REGULATION OF THE WATERWAYS OF THE CITY OF NAPLES, FLORIDA; AMENDING SECTION 1-15, GENERAL PENALTY; CONTINUING VIOLATIONS; ADJUDGING FINES AND IMPRISONMENTS, OF CHAPTER 1, GENERAL PROVISIONS; AMENDING SECTION 42-171, DEFINITIONS; AMENDING SECTION 42-172, AREA OF ENFORCEMENT; AMENDING SECTION 42-173, EXEMPTIONS; REPEALING SECTION 42-174, CAREFUL AND PRUDENT OPERATION REQUIRED; RENUMBERING SECTION 42-175, FINES TO 42-174 AND AMENDING SAID SECTION; REPEALING SECTION 42-176, SPEED GENERALLY; REPEALING SECTION 42-177, SPEED LIMIT IN CERTAIN RESTRICTED AREAS; REPEALING SECTION 42-178, SPEED GREATER THAN IS REASONABLE UNDER CONDITIONS; REPEALING SECTION 42-179, USE OF SEARCHLIGHTS, HORNS, WHISTLES OR BELLS; AND REPEALING SECTION 42-180, GARBAGE DISPOSAL, OF CHAPTER 42, WATERWAYS, OF THE CODE OF ORDINANCES, CITY OF NAPLES, FOR THE PURPOSE OF CREATING A MANATEE PROTECTION ZONE FOR DOCTORS PASS AND THE MOORINGS BAY SYSTEM; PROVIDING FOR CONFLICTING PROVISIONS, SEVERABILITY AND APPLICABILITY; REPEALING ORDINANCE 04-10664; AND PROVIDING AN EFFECTIVE DATE.**

All interested parties are invited to appear and be heard with respect to said proposed ordinances.
