

NOTICE OF PUBLIC HEARING ON PROPOSED ORDINANCES

NOTICE is hereby given that the Naples City Council will consider enactment of the following ordinances upon Second Reading at the Regular City Council meeting to be held on Wednesday, November 20, 2013, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

AN ORDINANCE RELATING TO THE NAPLES SQUARE PLANNED DEVELOPMENT FORMERLY KNOWN AS THE RENAISSANCE VILLAGE PLANNED DEVELOPMENT; DETERMINING REZONE PETITION 13-R4 TO REZONE APPROXIMATELY 21.1 ACRES FROM PD PLANNED DEVELOPMENT (FORMERLY RENAISSANCE VILLAGE) TO PD PLANNED DEVELOPMENT (NAPLES SQUARE) IN ORDER TO ALLOW FOR A NEW MIXED USE DEVELOPMENT CONSISTING OF FOUR MULTIPLE FAMILY RESIDENTIAL BUILDINGS AND FUTURE COMMERCIAL STRUCTURES ON PROPERTY OWNED BY WSR OLD NAPLES, LLC AND LOCATED AT 300 GOODLETTE FRANK ROAD, MORE FULLY DESCRIBED HEREIN; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

AN ORDINANCE AMENDING SUBSECTION (1) OF SECTION 2.5 OF THE CHARTER OF THE CITY OF NAPLES RELATING TO THE COMPENSATION AND BENEFITS FOR THE MAYOR AND CITY COUNCIL MEMBERS TO PROVIDE A STIPEND OF \$400.00 PER MONTH FOR THE MAYOR AND A STIPEND OF \$200.00 PER MONTH FOR MEMBERS OF CITY COUNCIL; INDICATING NO CHANGE IN HEALTH BENEFITS; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

Said proposed ordinances may be inspected by the public at the office of the City Clerk, Room B, City Hall, 735 Eighth Street South, Naples, Florida.

All interested parties are invited to appear and be heard with respect to said proposed ordinances.
