**AIRPORT AUTHORITY (2 vacancies)** An autonomous body appointed by the City Council to oversee operation of the Naples Airport. Members of the Airport Authority must be domiciled in the city limits. Terms 4 years. (9/6/14 – 9/5/18) Meets 3rd Thurs. at 8:30 a.m. Average meeting time: 3 hours. Interviews to be conducted at June 9<sup>th</sup> Council Workshop.

**BOARD OF CARVER FINANCE, INC. (1 vacancy)** 3-member board which provides oversight to the George Washington Carver Apartments and normally meets annually to review financial statements and audits. Terms: 3 years. (5/21/14 – 5/20/17). Average meeting time: 1 hour.

**CITIZENS POLICE REVIEW BOARD (3 vacancies)** 5-member body. Provides impartial forum to review closed departmental investigations of complaints against police officers made by citizens. All members must be domiciled within the City. Meets at least annually. Terms: 3 years. (4/6/14 – 4/5/17) Average meeting time: 1 hour.

**CODE ENFORCEMENT BOARD (1 regular and 2 alternate member vacancies. Whenever possible, board is to contain an architect, businessperson, realtor, engineer, general contractor and sub-contractor.)** Quasi-judicial body of 7 members and 2 alternates. Hears and decides alleged violations of any codes and ordinances for which there is no criminal penalty, and may impose fines for violations and record liens for non-payment of fines. Terms: 3 years. (alternate 1/19/14 – 1/18/17; regular 4/6/14-4/5/17) Meets 4th Thurs. at 2:00 p.m. Average meeting time: 1.5 hours.

**COLLIER COUNTY AFFORDABLE HOUSING ADVISORY COMMITTEE (2 City resident vacancies, 1 of which to be a not-for-profit provider of affordable housing)** Makes recommendations to the City and County on a variety of affordable housing issues. Terms: 3 years. (2/18/14 – 2/17/17) Meets 1st Mon. at 3 p.m. in the County Commission Chamber. Average meeting time: 2 hours.

**COMMUNITY REDVELOPMENT AGENCY ADVISORY BOARD (1 vacancy for a business owner, property owner or resident of the Community Redevelopment Area, which is generally the area bounded by 7<sup>th</sup> Avenue North, 6<sup>th</sup> Avenue South to the Gordon River and 3<sup>rd</sup> Street)** 7-member board which advises the Community Redevelopment Agency by providing public input and technical advice on land use, economic and other issues within the City's redevelopment district, and reviews certain petitions within the district. Terms: 2 years. (1/20/14-1/19/17) Meets 4th Monday at 9:00 a.m. Average meeting time: 1 hour.

**DESIGN REVIEW BOARD (2 regular vacancies for architects)** 5-member board with 1 alternate which reviews all land use petitions associated with architectural and landscape/architectural plans. Applicants may be either registered Florida architects or landscape architects or must have backgrounds allowing interpretation of design and related matters. City residency is required for non-architects. Terms: 3 years. (5/1/14-4/30/17) Meets 4th Weds. at 9:00 a.m. Average meeting time: 2 hours.

**EAST NAPLES BAY CITIZENS ADVISORY COMMITTEE (3 vacancies for residents of the East Naples Bay District boundaries. Members must live in Oyster Bay, Golden Shores or Royal Harbor)** This committee is charged with the responsibility of making recommendations to the City Council on a variety of issues within this canal maintenance district such as maintenance dredging, canal cleanup, and maintenance of private aids to navigation. Terms: 3 years. (10/1/13-9/30/16) Monthly as called. Average meeting time: 1 hour.

**METROPOLITAN PLANNING ORGANIZATION (MPO) CITIZENS ADVISORY COMMITTEE (CAC) (2 City resident vacancies)** The purpose of the CAC, as representatives of Collier County, shall be to advise the Collier MPO by reviewing, reacting to and providing comment on transportation planning issues and needs. The role and function of the CAC member shall consist of: assisting the MPO in the formation of goals and objectives for improving the urbanized area transportation system, conducting public information programs, providing a citizens review of comment on preliminary findings and recommendations of the ongoing transportation planning efforts and assists in other functions as requested by the MPO. Nominations for CAC members are recommended by the corresponding MPO Board member representing the City of Naples for ratification by the MPO Board. The CAC meets on the last Mon. at 2 p.m. at the MPO Offices, located at 2885 S. Horseshoe Drive, Naples. Terms: 3 years (5/15/13 – 5/14/16) Average meeting time: 2 hours.

**MOORINGS BAY CITIZENS ADVISORY COMMITTEE (2 vacancies for residents of the Moorings Bay District boundaries. Members must live along the shores of the Moorings Bay System from Seagate Drive to Banyan Boulevard)** 5-member committee charged with making recommendations to the City Council on a variety of issues within this canal maintenance district such as maintenance dredging of canals and waterways, including Doctors Pass, as well as maintenance of aids to navigation. This is an ideal committee for those interested in boating, fishing or water issues. Terms: 3 years. (4/6/14-4/5/17) Meets monthly as called. Average meeting time: 1 hour.

**PLANNING ADVISORY BOARD (1 regular member vacancy)** 7-member board with one alternate. Reviews a wide range of land use, planning and zoning issues. Terms 3 years; however current vacancy is for the balance of an unexpired term. (5/7/14 – 4/30/15) Meets 2nd Weds. at 8:30 a.m. and as needed for workshops. Average meeting time: 3 hours.

*Unless otherwise specified, all members of boards and committees must meet city residency requirements and are subject to state and local ethics laws; some are also subject to State of Florida financial disclosure requirements. Applications should be submitted as soon as possible.
