Department records indicate that the FGUA-Golden Gate public drinking water system violated Rule 62-550.830, violated Rule 62-550.830, Florida Administrative Code (F.A.C.), because it failed to submit a completed Level 1 Assessment form to the 1 Assessment form to the Department by no later than February 16, 2018. The water system also failed to notify the State within 24 hours of the Treatment Technique violation resulting from the failure to submit the Level 1 Assessment. The water system was required to perform the was required to perform the Level 1 Assessment following a situation where greater than 5% of the routine Bacteriological samples that were collected from its distribution system during the month of December 2017, were Total coliform-positive. Although public health was not Although public health was not impacted, as our customers, you have a right to know what happened, and what we did to correct the situation.

#### **HEALTH EFFECTS**

We were required to report the results of the Level 1 Assessment to the Department by no later than February 16, 2018. The results of the Assessment are meant to be an indicator of whether or not an indicator of whether or not your drinking water meets health standards. It was also meant to be a self-assessment performed by Utility personnel for the purpose of identifying (and ultimately correcting) any sanitary defects that may have made the water system vulnerable to contamination vulnerable to contamination during the month of December

### WHAT SHOULD CUSTOMERS

There is nothing you need to do. You do not need to boil your water or take other corrective actions. Please note that this utility, as of March 1st, 2018, is no longer an FGUA system.

### WHAT IS BEING DONE?

While we did not submit the appropriate Assessment appropriate Assessment form to the Department as quickly as we should have, we completed the Level 1 Assessment successfully on 1/29/2018 and submitted to the Department 2/27/2018.
