AN ORDINANCE RELATING TO ADMINISTRATION OF THE CITY FIRE-RESCUE DEPARTMENT; AMENDING SUBTITLE AND CATCHLINE OF DIVISION 5 - DEPARTMENT OF POLICE AND FIRE, UNDER CHAPTER 2 ADMINISTRATION, ARTICLE IV - DEPARTMENTS; AMENDING SECTION 2-381; CREATING A NEW SECTION 2-382; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.
