NOTICE is hereby given that the Naples City Council will consider enactment of the following ordinance upon Second Reading at the Regular City Council meeting to be held on Wednesday, October 17, 2018, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

AN ORDINANCE RELATING TO ADMINISTRATION OF THE CITY FIRE-RESCUE DEPARTMENT; AMENDING SUBTITLE AND CATCHLINE OF DIVISION 5 - DEPARTMENT OF POLICE AND FIRE, UNDER CHAPTER 2 ADMINISTRATION, ARTICLE IV - DEPARTMENTS; AMENDING SECTION 2-381; CREATING A NEW SECTION 2-382; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.
