**PUBLIC NOTICE OF SPECIAL ELECTION
CITY OF NAPLES, FLORIDA**

NOTICE IS HEREBY GIVEN that the City of Naples will have a special election on April 2, 2019 to elect a Naples City Council Member for the remainder of a term ending on February 1, 2022.

Candidates must be qualified electors and residents of the City of Naples for at least six (6) months prior to the first day of qualifying. Candidates are elected at large, by the highest number of votes.

The qualifying period shall commence at 8:00 a.m. on Monday, January 28, 2019, and shall close at 5:00 p.m. on Friday, February 8, 2019. All candidates shall qualify with the City of Naples City Clerk's Office located at Naples City Hall, 735 8th Street South, Naples, FL 34102.

Qualifying papers are now available in the City of Naples City Clerk's Office. In accordance with F.S. 99.061 (8), the City Clerk's Office may accept and hold qualifying papers submitted not earlier than 14 days prior to the beginning of the qualifying period, to be processed and filed during the qualifying period.

To qualify, a candidate must pay the required qualifying fee and one percent (1%) Florida Election Assessment fee required by F.S. 99.093 for the office he/she seeks. A candidate must also file the required documents outlined by the City Clerk, together with a filing fee of \$25.

De acuerdo con F.S.99.061(8), la Oficina de la Secretaria de la Ciudad puede aceptar y conservar los documentos cualificados presentados no antes de 14 días antes del comienzo del período de cualificación, para ser procesados y archivados durante el periodo de calificación.

Para calificar, los candidatos deberán de pagar la tarifa de cualificación requerida equivalente al uno por ciento (1%) del salario anual de la oficina solicitada según lo estipulado en los estatutos de la Florida, 99.093 F.S. Los candidatos también deberán presentar los documentos requeridos a la Secretaria Municipal, junto con una cuota de \$25.
