**Flood Elevation Variance FV19-02** City Council sitting as the City of Naples Board of Appeals is asked to consider a resolution determining Board of Appeals Petition BOA FV19-02 for the variance request, from the Subsection 1201.3 of the 6th Edition Florida Building Code, Existing Building for Historic Structures in order to allow a substantial improvement to an eligible historic structure that is below the required flood elevation of 13.0 without requiring the owner to raise the structure up to the required flood elevation.
