There are two ways to vote in the 2019 City of Naples Special Election:

Vote-by-Mail: The last day to request a vote-by-mail ballot to be mailed by the Supervisor of Elections Office is Wednesday, March 27 priojUr to 5:00 p.m. Vote-by-mail ballots will be mailed to the address on file with the Supervisor of Elections Office and cannot be forwarded. Voters must sign the Voter's Certificate prior to mailing.

Election Day: On Election Day, April 2, the polls will be open at 7:00 a.m. and will close at 7:00 p.m. Voters must bring a photo and signature ID with them to vote and must vote at their assigned precinct. All polling locations are ADA compliant.
