Once the zoning in progress is completed, applications will be processed based on the existing height ordinances. During the Zoning in progress, property owners should not assume stability in the code upon which they can rely in making investment backed decisions concerning the possibility of variances to City's height restrictions regarding buildings that may be built on their property. Rather, they are on notice that there are proposed changes to the code that could eliminate variances for height. Florida case law (specifically Smith v. City of Clearwater, 383 So.2d 681 {Fla. 2d DCA 1980}) and other law provides that the right to claim estoppel of the government or vested rights in pre-existing zoning ceases when there is reasonable notice or knowledge that a change of zoning is in progress. Unless extended, the Zoning in Progress will expire 180 days after the effective date.
