Naples Community Hospital is seeking approval to construct a hospital building in excess of 3 stories and 42 feet in height on the current NCH campus to accommodate a new Heart, Vascular, and Stroke Institute and accompanying parking structure. In order to accomplish this, NCH must rezone the property from the M, Medical District to the PS, Public Service District, obtain approval of a conditional use petition for the community hospital, and obtain approval of a site plan from City Council.

NCH has accordingly submitted Rezone Petition 23-R3 to rezone the subject property located at 350 7th Street North from the M, Medical District to the PS, Public Service District.
