NOTICE is hereby given that the Naples City Council will consider enactment of the following ordinances upon Second Reading at the Regular City Council meeting to be held on Wednesday, February 1, 2017, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

AN ORDINANCE DETERMINING REZONE PETITION 16-R7 REZONING APPROXIMATELY 5 ACRES FROM PD, PLANNED DEVELOPMENT TO PD, PLANNED DEVELOPMENT, TO ADD SPECIFIC PERMITTED USES INCLUDING RESIDENTIAL AT 12 UNITS PER NET ACRE WITH ASSOCIATED DEVELOPMENT STANDARDS CUSTOMIZED TO CONTEXT AND EXISTING CONDITIONS TO REMAIN FOR PROPERTY LOCATED AT 704/708 GOODLETTE-FRANK ROAD NORTH, OWNED BY ARTHUR L. ALLEN; MORE PARTICULARLY DESCRIBED HEREIN; ADOPTING THE PLANNED DEVELOPMENT DOCUMENT AS AMENDED HEREIN; AND PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

AN ORDINANCE RELATED TO AMENDING SECTION 22-37(C) (14), NOISE, CODE OF ORDINANCES, CITY OF NAPLES, TO ADD EASTER SUNDAY AS A DAY WHEN LAWN MAINTENANCE AND TREE TRIMMING ACTIVITIES ARE PROHIBITED, PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

AN ORDINANCE RELATING TO BOARDS, COMMISSIONS AND COMMITTEES; AMENDING SECTIONS 2-404 AND 2-405, ARTICLE V, BOARDS, COMMISSIONS AND COMMITTEES, OF CHAPTER 2, ADMINISTRATION, OF THE CODE OF ORDINANCES, CITY OF NAPLES; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.

Said proposed ordinances may be inspected by the public at the office of the City Clerk, Room B, City Hall, 735 Eighth Street South, Naples, Florida.

All persons are invited to appear and be heard with respect to said proposed ordinances.

Any person who decides to appeal any decision made by the City Council with respect to any matter considered at the above hearing will need a record of the proceedings and may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be heard.
