NOTICE is hereby given that the Naples City Council will consider enactment of the following ordinance upon Second Reading at the Regular City Council meeting to be held on Wednesday, June 7, 2017, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

AN ORDINANCE RELATING TO TREE PROTECTION; AMENDING CHAPTER 38, VEGETATION, OF THE CODE OF ORDINANCES OF THE CITY OF NAPLES, BY DELETING ARTICLE I. IN GENERAL, AND DELETING ARTICLE II. TREE PROTECTION AND REPLACING WITH A NEW ARTICLE I. IN GENERAL AND A NEW ARTICLE II. TREE PROTECTION; IN ORDER TO UPDATE AND STRENGTHEN REGULATIONS FOR PROTECTION OF TREES, TO REMOVE OUTDATED REGULATIONS, AND TO PROVIDE METHODS OF ENFORCEMENT AND PENALTIES; PROVIDING FOR CONFLICT AND SEVERANCE; PROVIDING A REPEALER PROVISION; PROVIDING AN EFFECTIVE DATE FOR IMPLEMENTATION OF FEE ADJUSTMENTS; AND AN EFFECTIVE DATE.

Said proposed ordinance may be inspected by the public at the office of the City Clerk, Room B, City Hall, 735 Eighth Street South, Naples, Florida.

All persons are invited to appear and be heard with respect to said proposed ordinance.

Any person who decides to appeal any decision made by the City Council with respect to any matter considered at the above hearing will need a record of the proceedings and may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be heard. Any person with a disability requiring auxiliary aids and services for this meeting may call the City Clerk's Office at 213-1015 with requests at least two business days before the meeting.
