**NOTICE** is hereby given that the Naples City Council will consider enactment of the following ordinances upon Second Reading at the Regular City Council meeting to be held on Wednesday, October 4, 2017, at 8:30 a.m., or as soon thereafter as may be practicable, in the City Council Chamber, 735 Eighth Street South, Naples, Florida:

**AN ORDINANCE RELATING TO FERTILIZER USE AND MAINTENANCE OF URBAN LANDSCAPES; AMENDING CHAPTER 52 OF THE CITY OF NAPLES CODE OF ORDINANCES, BY DELETING ARTICLE VII. LAWN AND LANDSCAPE MAINTENANCE AND CONTENT OF FERTILIZER AND REPLACING WITH A NEW ARTICLE VII. FERTILIZER USE AND MAINTENANCE OF URBAN LANDSCAPES; PROVIDING FOR: PURPOSE AND INTENT, DEFINITIONS, AND APPLICABILITY; TIMING, CONTENT, AND MEANS OF FERTILIZER APPLICATION; EXEMPTIONS; CERTIFICATION, TRAINING, AND LICENSING REQUIREMENTS; ENFORCEMENT AND PENALTIES; CONFLICT AND SEVERANCE; A REPEALER PROVISION; AND PROVIDING AN EFFECTIVE DATE. OF RATE ADJUSTMENTS; AND PROVIDING AN EFFECTIVE DATE.**

**AN ORDINANCE RELATING TO TRESPASS ON PUBLIC PROPERTY; CREATING AND ADOPTING A NEW SECTION 1-16 OF THE CODE OF ORDINANCES, CITY OF NAPLES, FLORIDA, AUTHORIZING ISSUANCE OF TRESPASS WARNINGS FOR CERTAIN VIOLATIONS; PROVIDING FOR AN APPEAL AND HEARING; PROVIDING AN ADMINISTRATIVE PENALTY; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.**
