**AN ORDINANCE RELATING TO ZONING AND LAND USE; AMENDING CHAPTER 58 OF THE CITY OF NAPLES CODE OF ORDINANCES; SECTION 58-116 GOVERNING MINIMUM YARDS; SECTION 58-121 GOVERNING PIER LOCATION AND DIMENSION REGULATIONS; AND SECTION 58-124 GOVERNING DRIVEWAY ENTRIES, WALLS, AND FENCES, IN THE R1-15A, RESIDENCE ZONING DISTRICT; ADOPTING TEXT AMENDMENT 17-T1; PROVIDING A SEVERABILITY CLAUSE, A REPEALER PROVISION AND AN EFFECTIVE DATE.**
