

DEPUTY DIRECTOR OF PUBLIC WORKS Streets & Stormwater Position Available

The award-winning City of Naples, Florida (population 19,372) is conducting a national recruitment for a Deputy Director of Public Works with a verifiable and highly successful record of accomplishment. Located in Southwest Florida, Naples has a total area of 16.4 square miles, of which 12.3 square miles are land. The City sits on the coast of the Gulf of Mexico, directly south of Fort Myers, north of Key West, and west of Ft. Lauderdale/ Miami. Incorporated as a municipality in 1923, the City will celebrate its Centennial year in 2023. The City of Naples is a council/manager form of government, comprised of an elected Mayor and six elected City Council Members to whom the City Manager reports.

THE DEPARTMENT

The City of Naples Public Works Department has a goal of providing the highest standard of service to our residents and customers by enforcing the City's vision plan related to Stormwater Management, Streets & Traffic and Resiliency & Sustainability.

STREETS & TRAFFIC

To provide a safe, clean and well-maintained transportation system of streets, sidewalks, bridges and pathways and to monitor and control the efficient operation of signalized intersections by way of the City's transportation operations center. Projects include annual street paving, and street light replacement program.



STORMWATER MANAGEMENT

The City of Naples Public Works Department has completed a Stormwater Master Plan along with several Basin Assessments to pave the way to improving flood protection and water quality through the construction, maintenance and operation of the public stormwater system and the preservation and restoration of area waterways. Design efforts are being finalized to construct the Basin II Beach Outfall Stormwater Project which is a \$36 million construction project along Gulf Shore Boulevard North that includes two (2) ocean outfall pump stations and truck lines. This project will remove the existing near shore stormwater outfalls and improve water quality.



RESILIENCY & SUSTAINABILITY

This division is part of the Stormwater Division with the responsibility to protect and restore ecological systems with work naturally to improve water quality, the environment and the quality of life for residents and visitors. Current projects include the Climate Adaption Plan and Vulnerability Assessment Update and canal dredging in the Royal Harbor community. Other responsibilities include Water Quality related to Naples Bay/Gordon River. Environmental Management related to artificial reef and oyster reefs. Environmental permitting for dredging projects and stormwater retention ponds within the City.



RESPONSIBILITIES



The purpose of the Deputy Public Works Director is to oversee the division activities within the Streets and Stormwater that include Stormwater Management, Resiliency & Sustainability (Natural Resources) and Streets & Traffic. Work involves technical and administrative work overseeing the construction, installation, maintenance, and repair of city streets, open drainage ditches, storm facilities and related infrastructure. Additionally manages design, permitting and construction inspection of special projects funded through other departments, State or Federal grants, or special assessment districts.

QUALIFICATIONS

- Bachelor's degree in Engineering, Civil Engineering, Environmental Engineering or related field; supplemented by seven (7) years of progressively responsible management experience in governmental related engineering project management related to stormwater system design and operations; street operations maintenance; or any equivalent combination of education, training and experience which provides the requisite knowledge, skills, and abilities for this position.
- Must possess and maintain a valid Florida Driver License, "Class E", with a driving record that meets or exceeds minimum City standards.
- Must possess and maintain certification as a Professional Engineer with the State of Florida.



OTHER IMPORTANT INFORMATION

The City of Naples is a Tobacco-Free Work Place.
