RESOLUTION 15-13734

A RESOLUTION ALLOCATING TWENTY-SIX (26) PARKING SPAGES WITHIN THE CITY OF NAPLES PARKING GARAGE LOCATED AT 801 6TH AVERUE SOUTH FOR THE REDEVELOPMENT OF THE PROPERTY LOCATED AT 560 9TH STREET SOUTH LLC; DETERMINING THE COST OF ALLOCATED PARKING SPACES; AND PROVIDING AN EFFECTIVE DATE.

- WHEREAS, Section 58-1134 (d) (2) of the Code of Ordinances provides that Sity Council may make public parking spaces available for allocation to meet required parking for new construction; and
- WHEREAS, public parking spaces are available for such allocation in the City owned parking garage at 801 6th Avenue South; and
- WHEREAS, City Council, by Resolution 08-12053, set the base price for a parking space at \$28,900 with direction to annually increase the price based upon the Consumer Price Index resulting in a current price per space of \$31,998; and
- WHEREAS, John M. Passidomo, Esq., Cheffy Passidomo, has been authorized by the petitioner and owner as agent for this petition; and
- WHEREAS, 560 9th Street South, LLC has requested the allocation of twenty-six (26) parking spaces from the parking garage located at 801 6th Avenue South for the redevelopment of the property located at 560 9th Street South; and
- WHEREAS, 560 9th Street South LLC has requested the price of the twenty-six (26) parking spaces from the parking garage located at 801 6th Avenue South for the redevelopment of the property located at 560 9th Street South be set at \$15,000 each; and
- WHEREAS, following an advertised public meeting on October 26, 2015, the Community Redevelopment Agency Advisory Board considered the public input, staff recommendations and criteria in the Code and recommended by a vote of 5 to 0 that Fifth Avenue South Parking Allocation Petition 15-PKAL2 be approved; and
- WHEREAS, after considering the recommendation of the Community Redevelopment Agency Advisory Board and after providing the petitioner, staff and the public an opportunity to present testimony and evidence, the City Council finds that the petition should be approved;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NAPLES, FLORIDA:

Section 1. That the allocation of twenty-six (26) parking spaces within the City of Naples parking garage located at 801 6th Avenue South for the redevelopment of the property located at 560 9th Street South is hereby approved.

Section 2.

That this allocation will consist of twenty-six spaces (26) purchased at the price

of \$20,000 each for a total purchase price of \$520,000.

Section 3.

That this resolution shall take effect immediately upon adoption.
