## **RESOLUTION 2018-14159**

A RESOLUTION AMENDING THE FY 2017-18 BUDGET ADOPTED BY RESOLUTION 2017-14027 TO APPROPRIATE FUNDS FROM GENERAL FUND CONTINGENCY FOR THE COST OF AN EXECUTIVE RECRUITMENT FIRM TO SEARCH FOR A SUCCESSOR CITY MANAGER AND RELATED EXPENSES AND FOR THE COST OF CONSTRUCTING A TEMPORARY PEDESTRIAN PATHWAY ALONG GULF SHORE BOULEVARD NORTH; AND PROVIDING AN EFFECTIVE DATE.

- WHEREAS, on February 23, 2018, City Manager William Moss, employed with the City of Naples since December 2007, notified City Council of his intent to retire effective January 2, 2019; and
- WHEREAS, on March 7, 2018, City Council agreed to seek the services of an executive search firm and developed a request for proposals; and
- WHEREAS, a request for proposals resulted in seven proposals received, reviewed and evaluated; and
- WHEREAS, on April 4, 2018, City Council selected Colin Baenziger & Associates to recruit a successor to the City Manager; and
- WHEREAS, Colin Baenziger & Associates' contract includes a fixed fee total of \$26,500; and
- **WHEREAS** costs associated with the interview process, such as candidate travel, accommodations and meals, are estimated to be \$10,000; and
- WHEREAS on April 4, 2018, City Council directed staff to develop a low-cost, temporary repair approach for damaged and vulnerable sidewalks along Gulf Shore Boulevard North that are adjacent to a private seawall while legal proceedings determine seawall ownership; and
- WHEREAS on May 16, 2018 staff presented, and City Council approved, a \$60,000 plan to create an alternative, temporary pedestrian pathway in three specific areas of concern;

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NAPLES, FLORIDA:

**Section 1.** That the FY 2017-18 budget of the City of Naples, adopted by Resolution 2017-14027, is hereby amended to appropriate \$36,500 from the General Fund Contingency to the City Manager Search line item to cover costs of the executive recruitment firm contract and related expenses.

## Resolution 2018-14159

- Section 2. That the FY 2017-18 budget of the City of Naples, adopted by Resolution 2017-14027, is hereby amended to appropriate \$60,000 from the General Fund Contingency to Non-Departmental to construct a temporary pedestrian pathway.
- Section 3. This resolution shall become effective immediately upon adoption.
