Meeting of 8/17/22****RESOLUTION 2022-14880**

A RESOLUTION FOR THE PURPOSE OF AMENDING THE FISCAL YEAR 2021-22 BUDGET, ADOPTED BY RESOLUTION 2021-14713, APPROPRIATING FUNDS FROM THE UNAPPROPRIATED FUND BALANCE OF THE ONE-CENT SALES TAX FUND, AND APPROVING A TASK ORDER TO VICTOR J. LATAVISH, PA INC. FOR ARCHITECTURAL AND ENGINEERING SERVICES TO RECONFIGURE AND HARDEN BAYS AT FIRE STATION NO. 2; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Naples adopted a budget on September 27, 2021 via Resolution 2021-14713; and

WHEREAS, during the budget process, City Council was advised the One Cent Sales Tax Fund would fund the project for architectural and engineering services for the renovation of the bays at Fire Station No.2; and

WHEREAS, the project is a renovation and hardening of the bays at Fire Station No. 2. to redesign the existing bays to provide increased space between the apparatus creating a safer environment for personnel and apparatus, preventing accidents, and reducing vehicle damage, while improving the City's critical infrastructure for emergency preparedness; and

WHEREAS, the project will complete the hardening to a Category 4 structure (130 mph) at Fire Station No. 2; and

WHEREAS, an RFQ requesting Letters of Interest for architectural assistance in redesigning the existing bays to provide increased space between the apparatus creating a safer environment for personnel and apparatus, preventing accidents and reducing vehicle damage, while improving the City's critical infrastructure for emergency preparedness was issued; and

WHEREAS, Victor J. Latavish, PA Inc. responded to the RFQ and was awarded a contract for architectural and engineering services with the City (Clerk Tracking No. 2019-00090) and is the firm selected and qualified to perform the required work by task order; and

WHEREAS, this project is an ongoing project, with the FY 2021-22 budget of \$75,000 intended for professional architectural and engineering services for reconfiguration and hardening of the apparatus bays at Fire Station No. 2; and

WHEREAS, due to unforeseen increases in building and architectural costs, the proposal for professional architectural and engineering services increased to \$125,750 for reconfiguration and hardening of City of Naples Fire-Rescue Department Station No. 2 apparatus bays; and

WHEREAS, staff recommends amending the budget of the One Cent Sales Tax project in the FY 2021-22 budget to \$125,750; and

WHEREAS, staff recommends award of a task order to Victor J. Latavish Architect, PA Inc. in the amount of \$125,750 for architectural and engineering services to harden the bays at Fire Station No.2;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NAPLES, FLORIDA:

Section 1. That the City of Naples FY 2021-22 budget, adopted by Resolution 2021-14713 is hereby amended to appropriate funds for the contract related to the hardening of the apparatus bays at Fire Station No.2.


Section 2. That the One Cent Sales Tax fund is amended to increase appropriations in the 350-08-10-522-560200-22Z07 account related to the reconfiguration and hardening of City of Naples Fire-Rescue Department Station No. 2 apparatus bays project by \$50,750 from the unappropriated fund balance of the One Cent Sales Tax Fund.

Section 3. That a task order is hereby awarded to Victor J. Latavish Architect, PA, Inc. in the amount of \$125,750 for architectural and engineering services to harden the bays at Fire Station No.2.

Section 4. That this resolution will take effect immediately upon adoption.
