A RESOLUTION FOR THE PURPOSE OF AMENDING THE FISCAL YEAR 2022-2023 BUDGET ADOPTED BY RESOLUTION 2022-14943 IN THE AMOUNT OF \$277,900 TO APPROPRIATE FUNDS FROM THE GENERAL FUND TO PROVIDE SUFFICIENT FUNDING FOR HARDWOOD AND PALM TREE TRIMMING AND AMENDING THE 3-YEAR CONTRACT WITH DAVEY TREE EXPERT COMPANY, RESOLUTION 2022-14978, TO INCREASE THE CONTRACT AMOUNT FROM \$1,950,000 TO \$2,227,900; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on November 16, 2022, City Council approved by Resolution 2022-14978 a 3-year contract in an amount not-to-exceed \$1,950,000 with Davey Tree Expert Company for hardwood and palm tree trimming; and

WHEREAS, the City Council wishes to amend the 2022-2023 Budget adopted by Resolution 2022-14943 by appropriating funds sufficient to pay for hardwood and palm tree trimming; and

WHEREAS, it is necessary to increase the contract amount by an additional \$277,900 in order to continue hardwood and palm tree trimming services; and

WHEREAS, City Council wishes to amend the 3-year contract in an amount not-to-exceed \$2,227,900 with Davey Tree Expert Company; and

WHEREAS, the City of Naples is a Tree City USA recipient; and

WHEREAS, the City of Naples manages an urban forest of 20,916 inventoried trees; and

WHEREAS, approval of this Resolution is in the best interest of the health, safety, and welfare of the residents of the City of Naples;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NAPLES, FLORIDA:

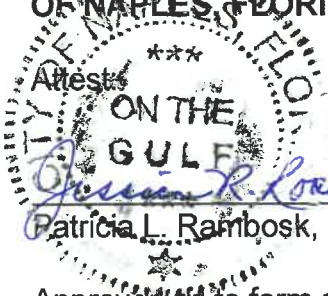
Section 1. That the above "Whereas" clauses are ratified, confirmed, and incorporated by reference as if set forth herein as the City Council's findings.

Section 2. That Resolution 2022-14978 is hereby amended to increase the 3-year contract amount with Davey Tree Expert Company from \$1,950,000 to an amount not-to-exceed \$2,227,900 for the continued hardwood and palm tree trimming services.

Section 3. That the Fiscal Year 2022-2023 Budget is hereby amended to appropriate \$277,900 from the General Fund to provide sufficient funding for these services.

Section 4. That this resolution shall take effect immediately upon adoption.
