Effective October 1, 2019

Bimonthly Water Base Charge

All City of Naples utility customers are charged a bimonthly base charge, even if no water is used. The rate is based on the chart to the right.

Bimonthly Water Consumption

In addition to the bimonthly base charge, all single family residential and commercial customers will be charged the following consumption rates according to their actual installed meter size, while Multi-family residences will be charges following consumption rates based upon the number of dwelling units. Customers with 1-inch meters who use from zero to 38,000 gallons are in Block 1. If their water usage increases from 38,001 to 75,000, then they move to Block 2. It is therefore most beneficial to use lowered amounts of water because the higher blocks are charged at higher rates.

Bimonthly Base Sewer Service Charge

The base bimonthly charge for single-family is \$39.64 and multifamily residences is \$30.92 per dwelling. In addition, each customer is charged consumption fee, based on the number of gallons of water used. Each single family dwelling has a 20,000 gallon bimonthly cap. The cap does not apply if an irrigation meter, sub-meter, or reclaimed water meter serves the property. No sewer charges are imposed on irrigation water meter flows.

Reclaimed (Irrigation) Water Charges

Reclaimed (irrigation) water has limited availability. The base bimonthly charge is based on the water meter size. addition the customer is charges a consumption fee based on the type of agreement they have with the City. If reclaimed water is available in the area, a base fee of \$20.02 bimonthly will be charged for availability whether the meter is connected or not. See the chart to the right for specifics.

Fees

The fee to test a water meter is \$68 for meters 5/8 inch to 1". The rate of testing meters 1 ½ inches and larger varies. Contact the Utilities Department at 213-4745 for additional information.

Late Fees

There is a 5 percent penalty assessed to utility accounts that are paid late.

Reinstatement of Water Service

When service has been cut off or discontinued for nonpayment of current bills, service will be reinstated upon prompt payment of unpaid bills, plus a service fee of \$26. When reinstatement is performed outside of normal working hours, per customer request, the fee is \$85. Normal working hours are 8 a.m. to 4 p.m., Monday through Friday, excluding holidays.

Reinstatement of Water Service after Meter is Locked

If water service has been discontinued for more than 5 days, by request or otherwise, the service line gate or curb stop valve will be locked in the off position. Reinstatement or unlocking of the meter is \$75. If this is performed outside of normal working hours, per customer request, the fee is \$135. Normal working hours are 8 a.m. to 4 p.m., Monday through Friday, excluding holidays. **Bad Check Fee Amount of Check**

Dishonored Checks

Per occurrence, the rate is based on the amount of the check.

The City of Naples provides solid waste collection based on an annual fee established by resolution and in the City Code Chapter 32 and the related Appendix. Commercial services need to review the City Code and contact the city directly for their needs. However, the following is the annual charge for residential property, as per the City Code.

Bimonthly County Base Sewer Service Charge

Individual Residential, non-residential and Multi-family Residential residents that live outside the City limits are charged County Sewer base rate that is related to the size of the meter. In addition, each customer is charged a consumption fee, based on the number of gallons of water used. The County sewer rates single family dwelling has a 30,000 gallon bimonthly cap.
