

RESOLUTION NO. 88-5469

A RESOLUTION CALLING FOR A REFERENDUM ON APPROVAL OF AUTHORIZATION TO LEVY AN AD VALOREM TAX MILLAGE NOT TO EXCEED ONE-HALF MILL WITHIN THE MOORINGS BAY SYSTEM SPECIAL TAXING DISTRICT; SETTING FEBRUARY 2, 1988, FOR SAID REFERENDUM; PROVIDING FOR BALLOTS; PROVIDING FOR NOTICE; AND PROVIDING AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NAPLES, FLORIDA:

SECTION 1. A referendum election shall be held on February 2, 1988, to determine whether or not the City Council shall be authorized to levy a Special District Tax millage, not to exceed one-half mill, in the Moorings Bay System Special Taxing District. This election shall be held together with the municipal election for the City of Naples.

SECTION 2. The result of such election shall be determined by a majority of the qualified electors of the District voting upon the question.

SECTION 3. Voting machines shall be used in such election, and the ballot title shall appear on the voting machine in the following form:

TITLE: Authorization for tax levy not to exceed one-half mill within the Moorings Bay System Special Taxing District.

SUBSTANCE: Are you in favor of authorizing an ad valorem tax levy of up to one-half (1/2) mill on real and tangible personal property within the Moorings Bay System Special Taxing District for the purpose of maintenance dredging in the canals and waterways within the area or boundary of the District, together with maintenance of necessary aids to navigation, inspection of seawalls and surveillance of surface water pollution.

SECTION 4. Absentee paper ballots may be used by qualified electors of the City of Naples for voting on this question for any reason set forth and prescribed in the Florida Statutes. The form of such absentee ballot shall be in accordance with the requirements prescribed by the election laws of Florida and shall have printed thereon the title and substance hereinabove set forth, with the proper places for voting either "yes" or "no."

SECTION 5. Notice of such election shall be published once a week for four (4) successive weeks beginning not less than thirty (30) days prior to the date of the election in a newspaper of general circulation in the City of Naples.

SECTION 6. The City Clerk is hereby authorized and directed to take all appropriate actions necessary to carry out the provisions of this resolution.

SECTION 7. This resolution shall take effect immediately upon adoption.
