- _____ 1. **The beach is a public access area and you cannot block or impede public access in any way.**
- _____ 2. Alcohol (without written approval) and Glass/Gambling/Vehicles on turf areas are prohibited on all city property.
- _____ 3. You may post the approved Reservation Form at site; Posting of any other signs is prohibited.
- _____ 4. Use of nails, staples, etc., on trees is prohibited. No chairs, tables, etc., are allowed on beach.
- _____ 5. Parking is **prohibited** in areas other than designated parking spaces and parking is limited.
- _____ 6. Guest parking and guest behavior is the responsibility of the event organizer.
- _____ 7. Areas used must be cleaned and trash deposited in dumpsters or risk loss of security deposit/additional charges.
- _____ 8. Any damage/loss must be replaced and/or repaired or will result in loss of security deposit additional charges.
- _____ 9. This application is for the date(s) & time(s) listed above and cannot be transferred or changed without approval.

Organizations must provide liability insurance (\$1 mil.), naming the **City of Naples 735 8th Street S. Naples, Florida 34102** as additionally insured.

- _____ 10. Rental/Event must be conducted in an orderly fashion at all times.
- _____ 11. Open Fires, including Tiki Torches, Grills (cooking on site), Fireworks, Bonfires, etc., are prohibited.
- _____ 12. Bounce houses are prohibited.
- _____ 13. Weddings are prohibited at Lowdermilk.
- _____ 14. Gazebo Rental is for small groups only. Large attendance, tents, etc., requires a Special Event Permit.
