Naples Dog Park Pass Tags are non-transferable between dogs/owners and may be revoked for non-compliance as may be required by the City. Naples Dog Park Pass Tag must be adhered to dog's collar. Additionally, each applicant is required to have thoroughly read and sign the Dog Park "Rules & Regulations". NOTE: This application is good for current calendar or license year only and must be renewed each year to verify that all immunizations have been updated.

I, do hereby acknowledge and accept that I have voluntarily applied to participate and utilize, with my dog(s), the City of Naples Dog Park located in the City of Naples, Florida. I fully understand and acknowledge that unleashing my dog and being physically present at the dog park area involves risks of injury to me, any individual accompanying me, other persons, my dog(s) and other dog(s), including but not limited to, risks resulting from aggressive dogs, unpredictable behavior and lack of proper training. I further understand and assume that despite the efforts of the City of Naples to ensure owners have complied, there is a risk that not all dogs present in the dog park are licensed and vaccinated for rabies as may be required, which could result in injury to a person or a dog.

HOURS OF OPERATION

1. DAWN to DUSK - 7 days per week weather and conditions permitting

RULES AND REGULATIONS

1. Pet owners are responsible for their dog's actions and behavior at all times. Dogs must be attended and supervised at all times by a person (persons) eighteen (18) years or older. Children under the age of eighteen (18) must be accompanied by an adult and closely supervised. No unattended dogs are permitted in the park at any time.

2. All dogs entering the park must receive an annual pass. Passes are dog specific, and a separate pass is required for each dog. Pass tags are not transferable between dogs and/or users or owners. Abandoning animals is prohibited by law. Pass tag must be visibly displayed on the dog's collar.

3. The owners of any dog and user of the park assume all liability for damages suffered by anyone who is bitten by a user's dog while utilizing the park, or by any dog that a user allows to enter the park.

4. Leashes may be removed only in the designated unleash area. No prong (pinch), choke or spiked collars are permitted in the park.

5. No more than two (2) dogs per person are permitted at one time in the park.

6. Pet owners must clean up after their dog. "Pooper Scooper" bags have been provided and must be utilized as may be required. Pet owners must pay close attention to their dog and properly pick up and dispose of their waste before leaving the park facility.

7. Aggressive or unruly dogs are prohibited from utilizing the park. A dog that is sick or a female dog in heat is prohibited in the Park. Spayed/neutered animals are recommended. Unneutered dogs must be closely monitored at all times. If a user's dog becomes unruly or plays too roughly, the offending dog must be leashed and leave the Park until such time that the dog is under owner control and has settled down.

8. All dogs must be licensed and properly immunized. Puppies under six (6) months are prohibited in the park. The use of heartworm and tick prevention products are recommended.

9. No smoking, alcohol, human food or glass containers are permitted in the park.

10. Only dogs and their owners are permitted within the park. No other animals (domesticated or not) may use the park. Professional dog trainers are not permitted to use the park for training purposes without written permission from the City.

11. A pass may be revoked if use or rule violations are reported or observed. The City should be notified as soon as possible by contacting the non-emergency Police at (239) 213-4844.
