A. PURPOSE OF REQUEST

The purpose of this Request for Proposal (RFP) is to contract with a firm to provide design and engineering services related to complete streets initiative improvements in the City of Naples, Florida along South Golf Drive.

Firms submitting must have expertise in roadway, sidewalk and drainage design and permitting services and any other requirements that the Florida Department of Transportation (FDOT) may impose in the Local Agency Program (LAP) Agreement for this project. Individuals and firms properly registered in the State of Florida are encouraged to submit their qualifications for consideration.

B. BACKGROUND

C. PROJECT

The principal intent of this project is to apply a complete street initiative along the South Golf Drive corridor, approximately 0.71 miles, between Gulf Shore Blvd North and US 41.
