The following answers to written submitted questions:

1. Do you possibly have the OEM part number for the battery you are currently using? The specs and dimensions listed in the bid are somewhat unusual and I want to ensure I am cross referencing the correct battery? Thank you for your help.

ANSWER: The current battery we have in use is the Clary OPB-1241. We are looking for batteries that meet or exceed our specs we put out, while also maintaining the same dimensions.

2. Can you please let me know some more detail on the batteries being requested? Sample details I am looking for are terminals on the battery, size requirements, amps/amp hours, etc.

ANSWER: The battery specs we are looking for are listed under our specification portion. For an example, we currently have the Clary OPB-1241 in use in our cabinets. We are looking for batteries that meet or exceed the listed specs we put out while also staying within the specified dimensions.

3. I am working on the attached bid opportunity for City of Naples. If you take a look at page # 23 there are 5 line items which sums up to total 510 batteries and on the page # 25 its mentioned under SOW that " This bid is for the purchase and delivery of 160 12VDC batteries". Please clarify that are the specifications same for 510 units or not ? and total units requested are 510 or 160?

ANSWER: Please reference page 27 of the bid document under Scope of Work that states" This bid is for the purchase and delivery of 160 12VDC batteries to provide reliable power to our traffic controllers and other sensitive equipment. Also, please reference page 4 section 15 of the General Conditions that states, "As the best interest of the City may require, the right is reserved to make award(s) by individual item, group of items, all or none, divide the award or a combination thereof; to reject any and all proposals or waive any minor irregularity or technicality in proposals received"

4. Battery Systems would like to see if we are able to bid on this solicitation? What battery (manufacturer & part number) is currently being used for this application?
