**THE FOLLOWING INFORMATION IS HEREBY INCORPORATED INTO,
AND MADE AN OFFICIAL PART OF THE ABOVE REFERENCED BID.**

The following answers to written, submitted questions:

1. Will other means of dredging besides mechanical be considered? We may propose to possibly dredging with divers and a pump.
(It was mentioned that the City would check with FDEP to clarify/confirm)

ANSWER: Yes, other means will be considered.

2. If the landfill requires testing on the material before delivering it and the material test positive for some contaminants, how will the city address this with the contractor?
(It was mentioned that the material is not expected to be contaminated)

ANSWER: If the specified Landfill requires testing, then the contractor will be responsible for providing this.

3. How will the city address the local permit fees?
(It was stated the city would pay/wave the fees)

ANSWER: The City will pay the fee for the permit. The contractor is required to submit for the permit.

4. Can the city confirm that the dredge material will be placed at the upland spoil area and hauled off as it dries out.

ANSWER: Confirmed. Material will be placed at the upland spoil area and then hauled off as it dries.

5. Is there an estimated budget available?

ANSWER: Pursuant to page 41, see Section E. LICENSES AND PERMITS.

7. Are timelines available for contract execution, notice of intent to award, and notice to proceed?

ANSWER: Pursuant to page 22, Section A; Terms of Contract; The resulting contract will commence on award and be in effect until completion of the project. Services to be rendered by the contractor shall be commenced subsequent to the execution of this Agreement upon written Notice to Proceed from the City for all or any designated portion of the Project must be completed by the contract dates specified within the Notice to Proceed for construction. Substantial completion must be reached for all aspects of the project no later than 90 days and fully completed no later than 60 days with a Project Close-out time frame of 30 days.

8. When is the anticipated start date?

ANSWER: The anticipated start date would be February 2024, but this will be discussed and scheduled with awarded contractor.

9. Is there any requirement for DBE, SBE, M/WBE or veteran participation?

ANSWER: No.
